

THE TOWN OF ASHBY'S COMMUNITY CHOICE POWER SUPPLY PROGRAM CONSUMER NOTIFICATION

The Town of Ashby is pleased to announce that **Hampshire Power** has been selected as the supplier for its Community Choice Power Supply Program ("Program"). Hampshire Power will provide electric power supply for all consumers participating in Ashby's Program. This notification is intended to tell you about this Program for electric power supply. In accordance with state law, it also informs you of your rights and options if you choose not to participate in the Program.

YOU WILL NOT NOTICE ANY CHANGE IN YOUR ELECTRICITY SERVICE. You will continue to see Hampshire Power printed under the "Supplier Services" section of your monthly bill. You will continue to receive one bill from Unitil. You will continue to send your payments to Unitil for processing. Unitil will continue to respond to emergencies, read meters and maintain the distribution and transmission lines. Reliability and quality of service will remain the same. Furthermore, you will continue to have all existing consumer rights and protections.
